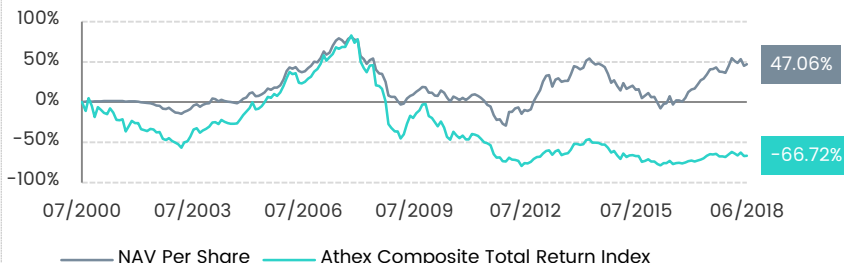

## Comparative Returns

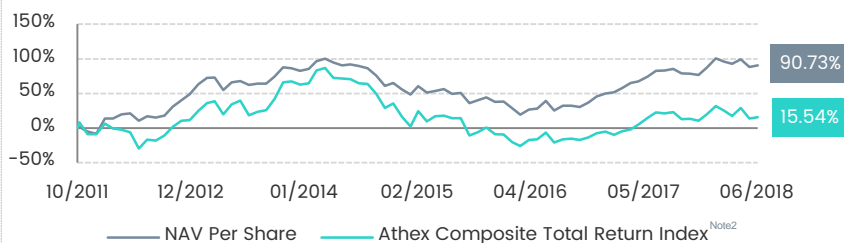
### Company Inception date
